It is a great honor to present The Hospice Promise Foundation's 2024 annual report. As I look back on the past year, I am filled with gratitude for our volunteers and for everyone whose ongoing support makes our mission possible. This report shares details on our performance in 2024, as well as a few stories that clearly demonstrate what a tremendous impact this program has on lives across the nation.

Because of your selfless generosity through donations and fundraising efforts, we were able to help patients and families find hope and comfort in the darkest of times. Trials and tribulations are a part of life, but with your kindness, compassion, and commitment to those we serve, we were able to make a transformative difference in the lives of so many in need of care, empathy, and a helping hand.

In 2024, we provided **856** grants totaling **\$937,594.55** for patients and their loved ones facing the end of life. Through our Educational Grant Fund, we were also able to provide **33** academic scholarships and professional certification grants totaling **\$44,029.89**.

As always, I want to thank our LHC Group employee family for their generous donations through payroll deductions – and LHC Group as an organization for funding our administrative expenses. 



Please take a moment to read these stories from the patients, families, and hospice professionals The Hospice Promise Foundation has supported. While these stories provide a closer and more personal look at the impact of our grants, we also want to share the scale on which we've been able to act.

In 2024, we helped:

- **500** patients in need write their own story at the end of life by helping ensure they had the funeral, burial, or cremation services they and their family desired.
- **160** patients keep the lights on and remain comfortable in their own homes, allowing them to focus on what matters most at the end of life.
- **25** patients fulfill their last wishes, ensuring quality of life with the time they had left and helping them live life on their own terms.

RAIN OR SHINE - HOSPICE IS THERE

ELITE HOSPICE - SEARCY

Searcy, AR

With help from The Hospice Promise Foundation, Elite Hospice in Searcy, Arkansas, was able to provide aid to a patient at a time they needed it most.

During a string of storms and inclement weather, one of Elite Hospice's patients was in dire need of assistance after a tree fell on their home, damaging their roof and caving in a part of the ceiling. The patient was concerned that they would not have enough funds to fix and replace parts of their home, especially since they had two children to take care of. It was the middle of January, and the patient was worried about providing adequate shelter to their children during the winter.



Seeing that their patient needed assistance, the team at Elite Hospice, along with the patient's social worker, came together to draft an application to The Hospice Promise Foundation on behalf of the patient. The Hospice Promise Foundation was able to quickly approve the patient's grant and provide assistance to help cover the cost of the home repairs.

The patient was able to fix their roof just in time for the arrival of winter weather. They were extremely grateful for The Hospice Promise Foundation's assistance and for the Elite Hospice team coming together to support one of their patients in their most desperate time of need.

PRECIOUS MEMORIES TO LAST A LIFETIME

UP HEALTH SYSTEM HOME CARE & HOSPICE

Escanaba, MI



The team at UP Health System Home Care & Hospice in Escanaba, Michigan, recently had a patient who was nearing the end of her illness. The patient and her daughter had one wish – to see each other again before she passed. Unfortunately, the patient’s daughter lived far away in New Mexico and did not have the necessary funds to make a trip to Michigan. Resigned to the fact that she would never see her mother in person again, the daughter would call her on Zoom or on the phone to speak with and see her.

Realizing how amazing it would be if they were able to reunite mother and daughter, the team at UP Health System Home Care & Hospice reached out to The Hospice Promise Foundation to see if there was any way they could help. Pastor Lewis Hague, Sarah Viau, RN, Jamie Pearson, social worker, and Andrew Porter, executive director, came together to create an application for the patient. The foundation approved their grant and helped cover the cost of the daughter’s flight. The hospice team was able to arrange the flight and even made arrangements for the daughter to have a place to stay during her visit with her mother.

The patient’s health had severely declined before her daughter came to see her. But when she was reunited with her daughter, the life came back into her eyes. For the next week, the patient and her daughter were able to share stories, reminisce, and make more precious memories together. And when it was time for the patient to move on from this world, her daughter was right there by her side.

Andrew Porter has worked in hospice for seven years. He noted that throughout the daughter’s visit, she expressed so much gratitude, breaking down into tears several times. For him, this was the greatest moment of his hospice career – his team helping to make this happen for the family.

The daughter was thankful to the hospice team in Escanaba for their support and for The Hospice Promise Foundation’s generosity. She was able to be with her mother in her final days and make beautiful memories that she will cherish her whole life.

DELIVERING THE JOY OF CHRISTMAS

HOSPICE OF LANCASTER AND THE PIEDMONT

Lancaster, SC

Meloda Danzy was a hospice patient at Hospice of Lancaster and the Piedmont in Lancaster, South Carolina. Shortly before Christmas, she was diagnosed with two aggressive forms of cancer. Her health rapidly deteriorated and she was unable to prepare for a normal Christmas with her son. Unfortunately, she passed away very quickly and left her seven-year-old son alone – without much preparation for a life without her.

Her son faced a multitude of adjustments due to her passing, and his family did not have the time or funds to get him Christmas presents. Although they had only known her for a short time, Meloda’s hospice team wanted desperately to deliver the joy of Christmas to her son and restore at least some normalcy in his life.

The team reached out to The Hospice Promise Foundation, asking for assistance to buy presents for their patient’s son. The foundation was able to approve their grant and cover the costs of buying presents. The foundation also sent the patient’s son a gift card for additional support during the holidays.

Thanks to the support from Hospice of Lancaster and the Piedmont, and the aid that The Hospice Promise Foundation was able to provide, Meloda’s son was able to enjoy Christmas and return to a sense of normalcy in the wake of massive adjustments he was forced to make. And while his mother was not able to be there with him during the holidays, her legacy touched the hearts of the team that worked with her, moving them to help deliver the joy of Christmas she wanted her son to have.

HEALING THE NOSE & MIND CERTIFICATE IN AROMATHERAPY

IDAHO HOME HEALTH & HOSPICE

Meridian, ID



Jennifer Li's story begins with a chance encounter with a special patient. During the pinnacle of COVID-19, Jennifer was just beginning her career as a nurse when she was assigned to care for a young man who had been seriously injured in a motor vehicle accident. When she walked into his room, she stopped immediately in her tracks. She had just entered the most calming and pleasantly scented room she had ever walked into during her short career as a nurse. Jennifer had never experienced a hospital room that smelled like this before. She learned that the patient's mom was bringing essential oils to diffuse the room and create a more healing environment for her son.

As she continued along her journey as a nurse, she moved from hospital care to hospice care, joining the team at Idaho Home Health & Hospice as a registered nurse. Throughout her journey, she met many patients who were either resistant to certain medications or conventional forms of treatment due to past personal or family history. Remembering the young man she cared for in the hospital all those years ago, and having learned more about the benefits of aromatherapy, she decided it was something she wanted to bring to her organization.

After bringing the idea to her team, her executive director contacted the Director of Complimentary-Integrative services at LHC Group and formulated a plan for Jennifer to earn her Certificate in Aromatherapy. They told her about The Hospice Promise Foundation and how it can help with costs of tuition through its educational grant program.

At first, Jennifer was hesitant. "The Hospice Promise Foundation is for patients in hospice care, I can't take money away from them, she said." Her executive director explained that there were two funds available: one for patients and one for educational grants. Hearing what the foundation could offer for her, she immediately applied to the program and reached out to the foundation. The Hospice Promise Foundation was able to cover a portion of her program costs and she was able to complete her certification.

Jennifer is thankful to the many donors who help sustain this fund. "A simple thank you is not enough to describe this amazing opportunity and gift," she said. "Here I stand, in a patient's home, sharing the beautiful art of aromatherapy and offering a distraction from their diagnosis and an alternative option to meet them where they are."



A SUPPORTIVE TEAM MAKES THE DREAM LPN TO RN

MEMORIAL WHITE ROSE HOSPICE
York, PA

Nykki Griffin started her career in 2013 after obtaining her LPN status. She worked as an LPN for seven years before realizing she wanted more out of her career. Thanks to the strong encouragement and support she received from her team at Memorial White Rose Hospice, she finally felt ready to take that step forward.

She credits Kevin Burgess, her quality and patient experience coordinator, as one of her biggest supporters and cheerleaders during her journey towards her RN license. He was always there to push her into following her dream. Nykki's teammates told her about The Hospice Promise Foundation and the educational grants they offer for nurses who are continuing their education. The foundation was able to reimburse her for some of her tuition costs and help her with expenses along her journey.

While she had a lot on her plate at the time – balancing work, school, family, and launching her own flower business – she was able to persevere thanks to the large amount of support and encouragement she received from her team. Her commitment, her team's support, and the support that The Hospice Promise Foundation was able to provide helped her push forward and complete her program.

Nykki was able to successfully complete her RN schooling in December 2024 and is now scheduling her boards and field work. "There have been many bumps in the road, but I was surrounded by supportive people," she said.
